- Most matters needing jurors have been rescheduled. We recognize this is a very challenging time and the Governor's order to Stay Home, Stay Safe is to be taken very seriously. ## **CRIMINAL**:

- The court will continue to hold in-custody arraignments, in-custody probation violation hearings, in-custody pleas/sentencings, in-custody probable cause hearings, in-custody release hearings, and in-custody substitution hearings. All such proceedings will occur at our Criminal Court Annex.
- The court will continue to hold in-custody trials, and hearings related to such trials, for defendants who are in custody on one or more criminal charge that provides them with a statutory or constitutional right to a speedy trial, where such rights have not been voluntarily waived, including defendants who have opted for bench trials. Such trials and hearings will occur at the downtown courthouse. Hearings shall be conducted by remote means if reasonably feasible and permitted by law.
- All out-of-custody trials and hearings scheduled through May 31, 2020, will be rescheduled for a status conference to be held on or after June 1, 2020. Trials shall be rescheduled at that time.
- The court will continue to conduct status conferences and pretrial hearings as scheduled on all criminal cases. Such proceedings shall be conducted by phone. Defense attorneys shall ensure that defendants sign a written acknowledgement of the next court date and return the acknowledgement to the court.
- Defendants cited to appear or with a release agreement to appear at the Criminal Court Annex prior to June 1, 2020, shall report to the Criminal Court Annex as directed by the citation or release agreement to receive further instructions from the court.
